If your complaint involves a violation or an alleged violation of a U.S. Center for SafeSport rule (i.e. sexual abuse, harassment, bullying), please contact the Center directly at 720.531.0340 or www.uscenterforsafesport.org. **There is no fee for filing a SafeSport complaint.**

If the U.S. Center for Safe Sport determines that they will not take jurisdiction of the complaint, the Center will forward the complaint to USA Surfing and it will be automatically submitted to the Judicial Committee for resolution.

The USA Surfing Judicial Committee has the authority to reduce or waive filing fee for reasons of significant financial hardship.
